## NATIONAL CENTER FOR VICTIMS OF CRIME LAUNCHES LAW ENFORCEMENT OUTREACH CAMPAIGN

**Arlington, VA** -The National Center for Victims of Crime, the nation's leading resource and advocacy organization for crime victims, today announced its *Last Step in First Response* initiative, a nationwide outreach campaign encouraging law enforcement professionals to put victims immediately in touch with the support and services they may need.

"As first-line responders, police officers and sheriffs are in a unique position to ensure that every crime victim has a place to turn in the aftermath of crime," said Susan Herman, executive director of the National Center for Victims of Crime. "The goal of this campaign is to help law enforcement help victims."

Each year, more than 28 million Americans are victimized by crime. "The emotional, financial, and legal impact of crime can be devastating," said Herman. "When crime strikes, most people are unprepared and simply unaware of where to go for assistance." The National Center operates the nation's most comprehensive information and referral program linking victims anywhere in the country with high quality, local services.

The National Center is distributing outreach materials--*small information cards designed to fit easily into a patrol car's glove compartment or on counter tops in police departments*--for law enforcement professionals to give directly to victims of crime. Victims are encouraged to call the National Center's Victim Services Helpline at 1-800-FYI-CALL to:

- Find the best available local services
- Understand the impact of the crime
- Access victim compensation
- Formulate safety plans
- Learn their legal rights and options
